("FMCTI") and Technip S.A. ("Technip"), each ordinary share of FMCTI beneficially owned by the Reporting Person at the effective time of the transaction contemplated by the Business Combination Agreement will be exchanged for 1.00 ordinary share of TechnipFMC.

2. Each share of phantom stock unit was the economic equivalent of one share of common stock of FMCTI. The phantom stock units were settled in common stock.
