RusTechnip⁽¹⁾ has been awarded a significant⁽²⁾ service contract for the existing Gazprom Neft Refinery located in Omsk, Russia.

The scope of work covers the engineering, procurement and construction management services (EPsCm) for the construction of a new Crude Distillation Unit – Vacuum Distillation Unit complex.

It will benefit from the knowledge gained during the FEED⁽³⁾ of the project, previously realized by the Group.

This award validates Technip's strategy of early involvement to design an effective project execution scheme.
